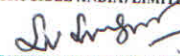

Notes:

- The Company is engaged in only one segment i.e. crucibles. Since 100% of the Company's business is crucibles, there is no other primary reportable segment. The said treatment is in accordance with the guiding principle enunciated in the Accounting Standard on Segment Reporting (AS-17) notified pursuant to Companies (Accounting Standards) Rules, 2006.
- The above results for the quarter and half year ended 30 September 2012 of the Company have been reviewed by Audit Committee at its meeting held on 09 November 2012 and thereafter approved by the Board of Directors at their meeting held on 09 November 2012. These results have been subjected to a "Limited Review" by the statutory auditors of the Company. The Limited Review Report does not contain any modification and has been filed with the stock exchange.
- With effect from 1 April 2012 the Company has changed its accounting policy for valuation of inventories from First in First Out (FIFO) method to Weighted Average Cost (WAC) method. This has resulted in figures for the six months ended 30 September 2012 (as reported above), for 'Cost of materials consumed' being lower by Rs. 12.41 lakhs, 'Changes in inventories of finished goods, work in progress and stock-in-trade' being higher by Rs. 09.12 lakhs, 'Other expenses' being lower by Rs. 1.40 lakhs and 'Net Profit for the period' being higher by Rs. 4.69 lakhs. If the FIFO method of valuation of inventories would have been followed, the figures for the six months ended 30 September 2012 for 'Cost of materials consumed' would have been Rs. 1,749.70 lakhs, 'Changes in inventories of finished goods, work-in-progress and stock-in-trade' would have been Rs. 117.05 lakhs, 'Other expenses' would have been Rs. 450.24 lakhs and 'Net Profit for the period' would have been Rs. 550.79 lakhs.
- Management charges for the year ended 31 March 2012 includes charges pertaining to previous year amounting to Rs. 151.85 lakhs.
- Tax expense includes provision for current tax and deferred tax.
- Figures for the previous period / year have been regrouped / rearranged wherever necessary.
